ORDER (PARNEET S SACHDEV- CHAIRMAN)

- 1. None appeared on behalf of the complainant.
- 2. On the last date of hearing, the respondent was directed to file reply.

 However, no reply has been filed by the respondent till date.

3. Upon perusal of the complaint file, it is revealed that the present complaint is filed by Mr. Sandeep Jain. However, the documents attached in the complaint file indicate that the plot in question was transferred from the respondent promoter to the original allottee, Mrs. Anita Narang vide BBA dated 30.11.2012. Subsequently, the plot was endorsed from the original allottee to Mrs. Sarita Jain on 30.09.2016, the wife of the complainant. However, this instant complaint has been filed by Mr. Sandeep Jain on behalf of his wife. The proforma-B, generated by the complainant, has also been generated on the name of Mr. Sandeep Jain instead of Ms. Sarita Jain, allottee.

4. The complaint was previously returned to rectify certain deficiencies, but an authority letter was received from Mrs. Sarita Jain on 22.07.2024. The relevant portion of the authority letter is reproduced below.

- 5. In light of these deficiencies, it is clear that the complaint is not properly constituted, and no relief can be granted under these circumstances. Additionally, the complainant has not been actively pursuing the case, having failed to appear before the authority both today and in the previous hearing.
