**ORDER** (Parneet S Sachdev-Chairman)

Present suo-motu complaint was registered against the respondent-promoter for not uploading quarterly progress reports of its real estate project namely "Gulmohar City" registered vide Registration No. HRERA-PKL-KTL-52-2018, dated 03.10.2018, valid upto March 2021.

2. A show cause notice was issued on 26.07.2022 for not uploading quarterly progress reports on the web portal of the Authority.

- 3. On 24.04.2023, Authority imposed a penalty of Rs. 1000/- per day till the QPRs are uploaded online.
- 4. On 28.08.2023, Authority imposed a cumulative penalty of Rs. 2,75,000/-. Since the promoter has not yet filed the QPRs the cumulative penalty from 24.04.2023 till today works out to Rs. 28,75,000/-. Authority also directed to show cause as to why penalty U/s 61 read with Section 63 & 60 be not imposed for contravention of the provisions of the Act and not complying with the orders of the Authority.
- 5. On 24.01.2024, the Authority enhanced the penalty from Rs.1000 per day to Rs.10,000/- and the office was directed to send a copy of the order to the respondent via mail and registered post. As per the directions of the Authority the copy of order was sent via registered post on 01.10.2024 which was returned as on 03.10.2024 addressee left without instructions however the orders were delivered via email on 27.09.2024.
- 6. Since the promoter has failed to upload the QPR's even after granting several opportunities, the penalty of Rs. 10,000/- per day imposed on 24.01.2024 is being enhanced to Rs.25,000 till quarterly progress reports are uploaded online.
  - It is further made clear that penalty of ₹25,000/- per day shall continue till the date quarterly progress reports are filed by promoter.
- 7. On 09.10.2024, learned counsel Sh. Tarun Ranga appeared on behalf of the Promoter requested for last opportunity to comply with the orders of the Authority.
- 8. On the last date of hearing i.e. 08.01.2025, Sh. Dinesh Gupta, Director of the company along with learned counsel Sh. Tarun Ranga appeared and submitted that QPRs till 30<sup>th</sup> June 2024 have been uploaded on 13.11.2024. The Authority directed the promoter to deposit an affidavit regarding no. of units sold and updated address of the company and further directed to

deposit the penalty of Rs. 37,40,000/- before next date of hearing i.e., 05.03.2025.

- 9. Today learned counsel Sh. Neeraj Goel appeared and requested for one more opportunity to comply with the orders of the Authority but The Authority declined the request and since the promoter had failed to deposit the penalty of Rs. 51.40 lacs till date therefore the Authority decided that the matter may be sent to the learned Adjudicating Officer (Execution) for recovering the same.
- 10. In view of the above, file should be transferred to the court of Ld. Adjudicating Officer (Execution) for taking further necessary action as per law.
