ORDER (PARNEET S SACHDEV - CHAIRMAN)

This suo-motu complaint was registered against the respondent for not uploading quarterly progress reports of project registered vide Registration No. HRERA-PKL-FBD-47-2018 dated 14.09.2018 valid upto 31.03.2019.

- 2. When the matter was heard on 20.03.2023, Authority imposed a penalty of Rs. 1,000/- per day till the quarterly progress reports are uploaded online.
- 3. The respondent has uploaded the quarterly progress reports upto June 2022 on 16.05.2023 and quarterly progress reports upto December 2022 on 26.05.2023.
- 4. The matter was heard on 26.07.2024 wherein the Authority observed that the cumulative penalty from 20.03.2023 till 15.05.2023 amounts to Rs. 57,000/-. The respondent was therefore directed to deposit the said amount in the registry of the Authority before the next date of hearing. Further, the respondent was also directed that as per the show cause notice dated 17.08.2022, it should file up to date quarterly progress reports till the time completion certificate is granted for the project, failing which Authority will be constrained to impose penalty under section 61 read with Section 63 for contravention of the provisions of the Act and not complying with the orders of the Authority.
- 5. The matter was heard on 10.01.2024 wherein it was observed that the promoter has not filed QPRs after December 2022. Therefore, he was burdened with a penalty of ₹1,000/- per day till up to date QPRs are uploaded online.
- 6. The matter was then heard on 10.07.2024 wherein penalty of ₹1,000/- per day imposed vide order dated 10.01.2024 was enhanced to ₹5000/- per day till upto date QPRs are uploaded online.



- 7. The matter was last heard on 20.11.2024 wherein it was observed that the respondent has filed QPRs upto 30.06.2024 on 30.08.2024. Hence, the cumulative penalty from 10.01.2024 till 29.08.2024 amounts to ₹4,38,000/- along with earlier penalty of ₹57,000/-. The respondent was directed to deposit the said amount in the registry of the Authority before the next date of hearing.
- 8. The respondent vide reply dated 22.01.2025 has deposited the penalty of ₹4,95,000/- vide demand draft no. 723243 dated 17.01.2025.
- 9. In view of above, Authority decides to discharge the show cause notice.
- 10. <u>Disposed of.</u> File be consigned to record room after uploading of orders on the website of the Authority.
