ORDER: (NADIM AKHTAR-MEMBER)

- 1. The operative part of the last order dated 11.11.2024 is reproduced below for reference:
 - 1. "As per last order, an adjournment was sought by Ld. Counsel for the respondent as CWP No. 9300 of 2023 and RERA appeal no. 55-56 of 2023 are pending for adjudication before the Hon'ble Punjab and Haryana High Court and interim stay has been granted.
 - 2. Today, Ld. Counsel for respondent informed that CWP No. 9300 of 2023 and the appeals filed therein are still lying pending for adjudication for 20.02.2025 before the Hon'ble Punjab and Haryana High Court and interim stay is continuing. An adjournment is requested by the respondent awaiting the outcome of the said CWP and appeals. Request of the respondent is allowed.
 - 3. Cases are adjourned to <u>24.03.2025</u> for awaiting the outcome of the said applications and Civil Writ Petition pending before the Hon'ble Punjab and Haryana High Court.
- 2. It is noted that the case is currently pending before the Hon'ble Punjab and Haryana High Court, and an interim stay has been granted on the proceedings before this Authority. While this Authority fully respects the Hon'ble High Court and its ongoing proceedings, it also has a responsibility to ensure that complaints are resolved quickly as per the Act. The repeated adjournments in this complaint, are causing delays and going against the purpose of fast resolution. However, since the Hon'ble High Court has put a stay on the

matter, this Authority cannot decide anything on merits in captioned complaint until the High Court gives its final decision. In the absence of a final decision from the Hon'ble High Court, it is not prudent to indefinitely keep the complaints pending on the file of the Authority.

- 3. In these circumstances, and in the interest of justice, the present complaints are dismissed without entering into the merits of the case. However, the complainants shall be at liberty to file fresh complaints before this Authority as and when the decision of the Hon'ble Punjab and Haryana High Court in CWP No. 9300 of 2023 is pronounced.
- 4. In view of the aforesaid observations, the present cases stand <u>dismissed</u> and disposed of accordingly.
