ORDER (NADIM AKHTAR - MEMBER)

- 1. Ld. counsels for the complainants reiterated the fact that insolvency proceedings qua the respondent company, i.e., Trishul Dream Homes Ltd. was initiated before the National Company Law Tribunal and moratorium under Section 14 of the Insolvency and Bankruptcy Code, 2016 has been invoked against the company.
- 2. In view of the statutory bar imposed under Section 14 of the Insolvency and Bankruptcy Code, 2016, and considering that the CIRP proceedings may continue for a substantial period of time, this Authority is precluded from proceeding with or adjudicating the present complaints at this stage. Therefore, Authority decides to dismiss the complaints without entering into the merits.
- 3. The complainants, however, shall be at liberty to file fresh complaints before this Authority as and when the decision of the Hon'ble NCLT is announced, upon the conclusion of the CIRP, and only if there is relief that the Authority can grant as per statute.
