 Since the core issues emanating from the above captioned complaints are similar in nature therefore all 16 matters have been taken together as a bunch. The complainant in complaint No. 1958 of 2023 and above

referred all other captioned complaints are allottees of the project namely "SRS City" located at Sector 6, Palwal being developed by the same respondent/ promoter, i.e., SRS Real Estate Ltd.

- Perusal of complaints reveals that all complaints were filed on 31.08.2023 and accordingly notices were issued on 01.09.2023 to respondent, however, despite several opportunities/attempt vide hearing dated 28.09.2023, 31.10.2023, 19.03.2023, 23.07.2024, 12.11.2024, notice could not be served to respondent since 01.09.2023.
- 3. Further, vide order dated 12.11.2024 Authority directed complainants to collect dasti notices from office of Authority, serve the same upon the respondent and file service report of the same in the Authority before next date of hearing. Furthermore, Authority also directed complainant to file some proof of builder buyer agreement in complaint no. 1958 of 2023 and 1975 of 2023 and to file proof of date of execution of builder buyer agreement in complaint is annexed with complaint is undated.
- 4. Today, at the time of hearing these matters there is no service of proof of notices available on record. Also, other aforesaid documents have not been filed. Since, the captioned matters are pending since year of 2023 for
