## **Proceeding-cum-Order**

The present complaint has been received on 30.01.2023 and the reply was received on 09.11.2023.

The counsel for the complainant states that complainant booked a unit on 18.03.2020 and paid Rs. 5,00,000/- as booking amount towards the unit. Subsequently, due to deadly spread of covid-19 the complainant was financially affected and suffered losses. Due to this, the complainant requested the respondent via email dated 13.04.2020 to cancel the booking of the unit and refund the amount paid towards the unit. Thereafter on 20.02.2021 the respondent terminated the unit and till date no amount has been refunded till date as neither any allotment letter is issued nor BBA is executed entitling the respondent to raise any further demands against the unit.

The counsel for the respondent states that the complainant himself withdrawn from the project due to the reasons best known to him and in case of voluntary cancellation, the entire booking amount would be forfeited as mentioned in terms and conditions of clause 13 of the booking application form.

However, the counsel for the respondent states at bar that respondent is willing to refund the booking amount of Rs. 5 Lakhs paid by the complainant.
