Proceedings-cum-order

The present complaint has been received on 11.01.2023 and the reply on behalf of the respondent was received on 18.05.2023.

The present complaint has been filed pleading for **possession** of the plot along with **delayed possession charges and execute the conveyance deed** and others documents as per law before the Authority.

The original allottee vide receipt dated 28.08.2006, has paid only an amount of Rs.5,00,000/- to the respondent/promoter. The original allottee has transferred her all rights, duties and liabilities to the present complainant i.e., Chhoti Devi through General Power of Attorney dated 05.09.2013. Thereafter, the subject receipt was transferred in the name of the complainant upon payment of the transfer fee amounting to Rs.6,25,000/- on 09.05.2014. The respondent confirmed the amount received and promised the allotment of a plot admeasuring 250 sq. yards. in the future potential project located in Gurugram.

Vide proceeding dated 30.04.2024, the counsel for the complainant submitted that the complainant allottee i.e. Chhoti Devi has expired and request for filing an application for impleading LRs of the deceased. A direction was given to the counsel to file the same in the registry before the next date of hearing.

Further, vide proceedings dated 13.08.2024, 12.11.2024 and 18.02.2025, the complainant were given various opportunities to file legal heir certificate.
