Proceedings-cum-order

The aforesaid complaint was disposed of vide order dated 18.03.2025 of the authority wherein the complainant was held entitled for DPC along with prescribed rate of interest. An application dated 15.04.2025 was filed by the complainant for rectification of proceeding of day dated 18.03.2025.

Vide said application for rectification of proceeding dated 18.03.2025, the complainants-applicants has submitted that the date of issuance of notice has wrongly been mentioned as 07.02.2024 instead of 07.10.20243.

It would be appropriate to refer to the provisions of Section 39 of the Act, 2016 under which the present application has been preferred.

"Section 39: Rectification of orders

The Authority may, at any time within a period of two years from the date of the order made under this Act, with a view to rectifying **any mistake apparent** from the record, amend any order passed by it, and shall make such amendment, if the mistake is brought to its notice by the parties.

Thus, the power conferred under Section 39 of the Act is limited to rectifying clerical or apparent mistakes in the orders issued by this Authority under the Act.
