It is observed that there is inadvertent error in the Order dated 06.05.2025 where complaint has been advertently mentioned as 22,45,862/- instead of 26,45,862/-. (same is evident as per statement of account annexed with reply at page 58, annexure R5 of the reply)

The Authority observes that the said error is inadvertent in nature. Therefore, in view of section 39 read with section 39 (2) of the Real Estate (Regulation and Development) Act, 2016 as the error is only clerical in nature and rectification in the order 06.05.2025 is allowed.
