Proceedings

The present application dated 25.07.2025 has been filed by the Respondent, seeking rectification of the order passed in Complaint No. 7902 of 2022, which was disposed of vide order dated 25.04.2025.

The present application under Section 39 of the Real Estate (Regulation and Development) Act, 2016 has been filed by the respondent seeking correction in the order passed by this Authority, on the ground that while pronouncing the order it was erroneously recorded in the table that the Occupation Certificate (OC) had not been received, whereas according to the respondent the OC had already been obtained.

The counsel for the respondent requests for updating the status of OC in table at serial No.16 of page 6 of the order which states that OC is not received and only in principle approval has been obtained on 21.09.2023. The copy of OC was not part of the reply but mentioned in the written submissions and inadvertently not considered, the copy of OC is also not placed at Annexure A2.
