#### **Proceedings**

The above-mentioned matter was heard and disposed of vide order dated 03.05.2024 wherein the Authority had directed the respondent to refund the paid up amount of Rs.15,67,110/- after deducting 10% of the sale consideration of Rs.59,68,869/- being earnest money along with interest at the rate of 10.85% as prescribed under rule 15 of the Rules from the date of cancellation 07.02.2023 till its realization.

The respondent has filed an application dated 25.03.2025 for rectification of order dated 03.05.2024 and the respondent is proposing following rectification as under: that the judgement passed by the hon'ble Authority needs to be rectified for a limited purpose that the amount paid by the complainant recorded in the judgement shall be corrected from Rs.15,67,110/to Rs.14,16,390/-.

The counsel for the complainant states that an appeal is pending in the Hon'ble Appellate Authority bearing appeal No.\_438/2024 and hence, the application
