Proceedings-cum-order

The present complaint was filed on 03.01.2025 and reply on behalf of the respondent was received on 30.07.2025.

The Authority observes that initially, the complainant had filed a complaint bearing No. 4763 of 2021 before the Authority, in which the Authority granted delay possession charges to the complainant from 20.03.2016 till the date of obtaining the Occupancy Certificate (OC) from the competent authority, i.e., 02.02.2022, plus two months.

The complainant has filed fresh complaint seeking directions to the respondent to execute the CD and to remove/justify the increase in the unit size from 1875 sq.ft. to 1950 sq.ft. leading to change in total sale consideration and issuance of new demand for EDC/IDC, to provide either the covered car parking or not charge for the car parking charges and to remove labour cess, Krishi kalyan cess and swatch Baharat cess from the offer of possession demand.

Heard.

The respondent is obligated to execute the conveyance deed in favour of the complainant in terms of Section 17 (1) of the Act, 2016 within 2 months. The
