Proceedings-cum-order

The present application for rectification, dated 06.05.2025, has been filed by the Complainant in Complaint No. 750 of 2022, which was previously disposed of vide order dated 28.01.2025.

In the said rectification application dated 15.07.2025, the Complainant has sought correction in respect of the total amount paid towards the allotted unit. It is submitted that the correct amount paid by the Complainant is ₹79,00,930/-, and the same has been erroneously recorded in the order dated 28.01.2025 as ₹72,33,504/-. Accordingly, this clerical/arithmetical error is liable to be modified and corrected in the interest of justice.

The counsel for the Respondent raised no objection to the same.
