Proceedings

The above-mentioned matter was heard and disposed of vide order dated 22.11.2024 wherein the Authority had directed the respondent to pay interest to the complainants against the paid-up amount at the prescribed rate i.e., 11.10% per annum for every month of delay on the amount paid by the complainants from the due date of possession i.e., 28.11.2018 till 12.01.2021 i.e., expiry of 2 months from the date of offer of possession (12.11.2020) or till actual handover of possession whichever is earlier as per provisions of section 18(1) of the Act read with rule 15 of the rules and section 19(10) of the Act.
