Proceedings-cum-order

The above-mentioned matter was heard and disposed of vide order dated 07.05.2025 wherein, the Authority had directed the respondent to pay interest to the complainant against the paid-up amount at the prescribed rate of 11.10% p.a. for every month of delay from the due date of possession i.e., 19.07.2016 till valid offer of possession plus 2 months after obtaining occupation certificate from the competent authority or actual handing over of possession, whichever is earlier, as per Section 18(1) of the Act of 2016 read with Rule 15 of the Rules.

The counsel for the complainant has filed an application for rectification of order dated 07.05.2025, stating that at page no.1 of the complaint, the name of the respondent has been recorded as "Imperia Structures Pvt. Ltd.", whereas the correct name of the respondent is "Imperia Structures Ltd." as per the records of the Ministry of Corporate Affairs and the pleading of the parties. Further, the complainant has paid a total sum of Rs.65,32,370/- against the unit in question, however, due to clerical error, the paid-up amount has been recorded as Rs.63,80,250/-, which requires due correction in the interest of justice.

As per the record, the name of the respondent is "Imperia Structures Ltd.", but the same has been inadvertently mentioned as "Imperia Structures Pvt. Ltd." in the final order dated 07.05.2025, due to clerical error.
