1. The address of the complainant has been incorrectly recorded as R/0-29, Sector 15 Part-I, Gurugram, Haryana-122001 at page no.1

It is observed that there is inadvertent error in the Order dated 22.04.2025 where the name of the complaint is inadvertently mentioned as "R/0-29, Sector 15 Part-I, Gurugram, Haryana-122001"

The correct name is "32/1, Masjid Wali Gali, Rajiv Chowk, Gurugram, Haryana-122001."

The Authority observes that the said error is inadvertent in nature. Therefore, in view of section 39 read with section 39(2) of the Real Estate (Regulation and Development) Act, 2016 as the error is only clerical in nature and rectification in the order 22.04.2025 is allowed. The counsel for the respondent has no objection to it.
