## ORDER (DR. GEETA RATHEE SINGH – MEMBER)

1. Complaint bearing nos. 1961, 1963, 1964, 1971, 1972, 1973, 1974, 1980, 1981 and 1984 of 2023 were disposed of vide order dated 20.05.2025 for the reason that they were pending since 2023 for service of notice and want of complete documents. However, complainants filed applications dated

10.06.2025 seeking restoration of aforementioned complaints. Restoration applications in aforementioned complaints were considered and allowed in the interest of justice. Accordingly, same were listed for re-hearing today.

- 2. Complaint bearing nos. 1940, 1942, 1943, 1944, 1946, 1947, 1949, 1950, 1951, 1952, 1953, 1954, 1955 and 1956 of 2023 were listed for hearing on 16.09.2025. However, due to the re-constitution of benches, complaints are taken up today for hearing.
