ORDER

1. The present complaint has been filed by the complainant/allottee under section 31 of the Real Estate (Regulation and Development) Act, 2016 (in short, the Act) read with rule 28 of the Haryana Real Estate (Regulation and Development) Rules, 2017 (in short, the Rules) for violation of section 11(4)(a) of the Act wherein it is *inter alia*

prescribed that the promoter shall be responsible for all obligations, responsibilities and functions under the provision of the Act or the Rules and regulations made thereunder or to the allottees as per the agreement for sale executed *inter se*.

A. Unit and project related details

2. The particulars of unit details, sale consideration, the amount paid by the complainants, date of proposed handing over the possession, delay period, if any, have been detailed in the following tabular form:

B. Facts of the complaint:

3. The complainant has made the following submissions: -
 - I. That on 29.07.2020 the complainant received a phone call from the associate of Mahira Homes 63-A regarding booking of residential flat in their affordable group housing colony. On 04.08.2020 the complainant applied for booking a 2 BHK flat with the respondent and paid a booking amount of Rs.1,05,000/-.
 - II. The draw was held on 08.12.2020 for allotment of flat in Sector-63-A but the complainant could not be successful. He applied for refund of his booking amount but the executives of the company told him that they are going to hold draw shortly their other project named Mahira Homes-95 and requested the complainant to adjust the booking amount in that project. The complainant agreed and applied on 23.03.2021 in Mahira Homes-95.
 - III. That on 22.06.2021, the draw was held and the complainant was declared successful and received the Allotment Letter on the same day vide which the complainant was allotted unit no. T7-101, Unit type- 2BHK, Type-B on Floor no. 1 in Tower-T7. The BBA was registered on 12.11.2021.
 - IV. That the complainant opted for construction linked plan and according to that plan, the complainant has till now made a payment of an amount of Rs.15,76,154/- out of the sale consideration of Rs.21,01,544/-.

V. That despite repeated calls by the complainant to the respondent, the directors, shareholders and other signatories are not answering the complainant's calls and have blocked his mobile number. That the complainant contacted the respondent on several occasions and were regularly in touch with the respondent for construction on regular basis. The complainant visited the construction site and was shocked to see no progress in the construction activity at site.

VI. That the respondent has played a fraud upon the complainant as well as on the Authority as the company M/s. Czar Buildwell Private Limited does not exist and is a forged entity. The CIN No. U70109HR2017ATC069536 as reflected on the site of the Authority is that of M/s. Mahira Buildwell Pvt. Ltd and no company by the name of M/s. Czar Buildwell Private Limited is available on the official site of registrar of Companies.

VII. That the License bearing no. 24 of 2020 for Mahira Homes-95 obtained from the DTCP, Haryana for Affordable Group Housing Colony on 6.05 acres failing under Sector-95, Gurugram has been cancelled and also been blacklisted due to forged signature, forged and fabricated Bank Guarantees.

VIII. Hence, the present complaint.

C. Relief sought by the complainant:

4. The complainant has sought following relief(s):

- Direct the respondent to refund the amount paid with interest @24% per annum paid by the complainant to the respondent till the date of realization of funds.

5. The present complaint was filed on 17.02.2025 and registered as complaint no. 313 of 2025. As per the registry, complainant has sent copy of the complaint along with annexures through speed post as well as through email. Vide proceedings dated 10.12.2025, no one appeared on behalf of the respondents and hence, the respondents were proceeded ex-parte.
6. Copies of all the relevant documents have been filed and placed on the record. Their authenticity is not in dispute. Hence, the complaint can be decided based on these undisputed documents and submission made by the complainant.

D. Jurisdiction of the Authority:

7. The Authority observes that it has territorial as well as subject matter jurisdiction to adjudicate the present complaint for the reasons given below.

E. I Territorial jurisdiction

8. As per notification no. 1/92/2017-1TCP dated 14.12.2017 issued by Town and Country Planning Department, the jurisdiction of Real Estate Regulatory Authority, Gurugram shall be entire Gurugram District for all purpose with offices situated in Gurugram. In the present case, the project in question is situated within the planning area of Gurugram district. Therefore, this authority has complete territorial jurisdiction to deal with the present complaint.

E. II Subject matter jurisdiction

9. Section 11(4)(a) of the Act, 2016 provides that the promoter shall be responsible to the allottees as per agreement for sale. Section 11(4)(a) is reproduced as hereunder:

Section 11(4)(a)

Be responsible for all obligations, responsibilities and functions under the provisions of this Act or the rules and regulations made thereunder or to the allottee as per the agreement for sale, or to the association of allottee, as the case may be, till the conveyance of all the apartments, plots or buildings, as the case may be, to the allottee, or the common areas to the association of allottee or the competent authority, as the case may be;

Section 34-Functions of the Authority:

34(f) of the Act provides to ensure compliance of the obligations cast upon the promoter, the allottee and the real estate agents under this Act and the rules and regulations made thereunder.

10. So, in view of the provisions of the Act quoted above, the Authority has complete jurisdiction to decide the complaint regarding non-compliance of obligations by the promoter leaving aside compensation which is to be decided by the adjudicating officer if pursued by the complainant at a later stage.
11. Further, the Authority has no hitch in proceeding with the complaint and to grant a relief of refund in the present matter in view of the judgement passed by the Hon'ble Apex Court in ***Newtech Promoters and Developers Private Limited Vs State of U.P. and Ors." SCC Online SC 1044 decided on 11.11.2021 and followed in M/s Sana Realtors Private Limited & others V/s Union of India & others SLP (Civil) No. 13005 of 2020 decided on 12.05.2022*** wherein it has been laid down as under:

"86. From the scheme of the Act of which a detailed reference has been made and taking note of power of adjudication delineated with the regulatory authority and adjudicating officer, what finally culls out is that although the Act indicates the distinct expressions like 'refund', 'interest', 'penalty' and 'compensation', a conjoint reading of Sections 18 and 19 clearly manifests that when it comes to refund of the amount, and interest on the refund amount, or directing payment of interest for delayed delivery of

possession, or penalty and interest thereon, it is the regulatory authority which has the power to examine and determine the outcome of a complaint. At the same time, when it comes to a question of seeking the relief of adjudging compensation and interest thereon under Sections 12, 14, 18 and 19, the adjudicating officer exclusively has the power to determine, keeping in view the collective reading of Section 71 read with Section 72 of the Act. if the adjudication under Sections 12, 14, 18 and 19 other than compensation as envisaged, if extended to the adjudicating officer as prayed that, in our view, may intend to expand the ambit and scope of the powers and functions of the adjudicating officer under Section 71 and that would be against the mandate of the Act 2016.”

12. Hence, in view of the authoritative pronouncement of the Hon'ble Supreme Court in the matter of **M/s Newtech Promoters and Developers Private Limited Vs State of U.P. and Ors. and M/s Sana Realtors Private Limited & others V/s Union of India & others (supra)**, the Authority has the jurisdiction to entertain a complaint seeking refund of the amount and interest on the amount paid by him.

E. Findings on relief sought by the complainant:

E.I Direct the respondent to refund the amount paid with interest @24% per annum paid by the complainant to the respondent till the date of realization of funds.

13. The complainant applied for the allotment in the affordable housing project i.e., “Mahira Homes-95” located in sector-95, Gurugram being developed by the respondent i.e., M/s Czar Buildwell Pvt. Ltd. The respondent intimated to the complainant about the allotment of unit no. T7-101 , Unit type-2BHK, Type-B on Floor-1st in Tower-T7 on 22.06.2021. The total sale consideration of the unit was Rs.21,01,544/- out of which the complainant has paid an amount of Rs.15, 76,154/- On knowing about the status of the project, the complainant requested

the respondent to refund the amount paid by the complainant as he wanted to withdraw from the project.

14. It is pertinent to mention that the Authority on 28.05.2022 initiated Suo-Motu action against the promoter under section 35 of the Act, 2016 based upon the site visit report submitted on 18.05.2022 wherein it is clearly stated that only excavation work for tower 2, 3 & 4 was started at site. Moreover, on 17.05.2022 the Director Town & Country Planning blacklisted the said developer from grant of license on account of submitting forged and fabricated bank guarantees and also forged signatures of the bank officials on the bank guarantees being submitted by M/s. CZAR Buildwell Pvt. Ltd which was subsequently withdrawn by the department on 21.07.2022 subject to fulfillment of certain conditions. Also, on 19.07.2022 all the accounts were freezed by the Authority due to non-compliance of the provisions of the Act, 2016. On 06.09.2023 the Authority initiated suo-moto revocation proceedings under section 35 of the Act, 2016. Thereafter, the Authority vide order dated 11.03.2024 revoked the registration certificate of the project under section 7(1) of the Act, 2016 and accordingly the respondent company shall not be able to sell the unsold inventories in the project and also, the accounts are freezed therefore, this amounts to discontinuation of business of the respondent.
15. The Authority considering the above mentioned facts opines that although the due date of possession has not lapsed yet, section 18 of the Act, 2016 is invoked if the promoter is unable to handover the possession of the unit as per the terms of the agreement **due to**

discontinuance of his business as developer on account of suspension or revocation of the registration under this Act or any other reason then the complainant shall be entitled for entire refund of the amount paid to the respondent along with the prescribed rate of interest. The relevant portion is reproduced herein below for the ready reference:

"Section 18: Return of amount & compensation:

(1) If the promoter fails to complete or is unable to give possession of an apartment, plot or building,-

(a) in accordance with the terms of the agreement for sale or, as the case may be, duly completed by the date specified therein; or

(b) due to discontinuance of his business as a developer on account of suspension or revocation of the registration under this Act or for any other reason,

he shall be liable on demand to the allottees, in case the allottee wishes to withdraw from the project, without prejudice to any other remedy available, to return the amount received by him in respect of that apartment, plot, building, as the case may be, with interest at such rate as may be prescribed in this behalf including compensation in the manner as provided under this Act:....."

16. The Authority is of the view that since vide order dated 11.03.2024 the registration certificate of the project stands revoked under section 7(1) of the Act, 2016 therefore, the promoter cannot carry out the business in presence of the said circumstances, also due to the promoter's serious violations, there seems no possibility of completing the said project by the due date. Thus, the Authority is of the view that the complainant is entitled to his right under section 19(4) to claim the refund of amount paid along with interest at prescribed rate from the promoter. Accordingly, the Authority directs the respondent to refund the paid-up amount of Rs.15,76,154/- received by it along with interest at the rate of 10.85% p.a. as prescribed under rule 15 of the

Haryana Real Estate (Regulation and Development) Rules, 2017 from the date of each payment till the actual realization of the amount.

F. Directions of the authority:

17. Hence, the Authority hereby passes this order and issue the following directions under section 37 of the Act to ensure compliance of obligations cast upon the promoter as per the function entrusted to the authority under section 34(f):
 - a. The respondent /promoter is directed to refund the amount i.e., **Rs.15,76,154/-** received by it along with interest at the rate of 10.85% p.a. as prescribed under rule 15 of the Haryana Real Estate (Regulation and Development) Rules, 2017 from the date of each payment till the actual realisation of the amount.
 - b. A period of 90 days is given to the respondent to comply with the directions given in this order and failing which legal consequences would follow.
18. Complaint stands disposed of.
19. File be consigned to registry.
