It is also a matter of concern that the project is to be completed as per decision of the Authority dated 23.1.2019. However, it is really a sad and matter of concern that nothing has happened as per the scheduled programme chalked out in that order. However, rather certain other questions have been raised by the objectors who have lended money to the promoter/Orris Infrastructure Pvt Ltd. The matter needs to be heard by the full bench so that the pragmatic approach for completion of the project is evolved at the earliest. RERA authority intends to get the project completed by the licence holder/promoters/ Three C Shelters Pvt Ltd. Since the Hon'ble apex court has now pronounced its judgment with regard to lifting of ban on construction activities in the NCR and now the construction activities can continue from 6.00 a.m. to 6.00 p.m. on daily basis. The promoter-M/s Orris Infrastructure Pvt.Ltd. as well as M/s Three C Shelters Pvt Ltd. are directed to start the construction and show their in genuinity failing which RERA authority shall be compelled to take coercive action.

Promoters/Directors of M/s Orris Infrastructures Pvt Ltd and M/s Three C Shelters Pvt Ltd. are directed to come present on the next date of hearing. Case is adjourned to 18.12.2019.
