ORDER (RAJAN GUPTA-CHAIRMAN)

1. The Authority has taken suo-moto cognizance through captioned complaints for recovery of costs from the respondent for delay in filing reply. In complaint no. 216, 215, 214, 196,195,197,198,217 of 2020 amount of Rs. 34000/- payable to the Authority and Rs. 4000/- payable to the complainant in each
