want of jurisdiction and the reply filed by the respondent has also been considered.

Counsel for the respondent has vehemently opposed the restoration of the complaint dismissed for want of jurisdiction on the ground that once the matter has attained finality, the authority has no power to review its own order whereas the counsel for the complainant is insisting for the sake of early decision in the matter, the complaint dismissed for want of jurisdiction be restored to its original number keeping in view the principle of natural justice.

Complainant is directed to file a fresh complaint before the authority and copy of the same be supplied to the counsel for the respondent to enable the authority to hear the matter on priority basis.

Application stands disposed of accordingly. File be consigned to the registry.
