Proceedings

As per the averment of the complainant, the due date of possession comes out to be 06.10.2011. However, after the receipt of occupation certificate dated 11.03.2013, possession has not been offered in a valid manner till 2013 when occupation certificate has been received.

There is also a dispute inter-se the buyer and builder/developer w.r.t. carpet area. He has also asked for information pertaining to his unit through email which has not been provided to him. He is asking for delayed possession charges from the due date of possession i.e. 06.10.2011 till handing over of possession.

In view of the matter stated above, since the occupation certificate of the project has been received by the respondent much prior to advent of RERA Act, as such, the matter is not maintainable in the eyes of law.
