Arguments heard partly on behalf of both the parties. The matter in issue involved in this case is whether the respondent/builder is liable to pay assured return to the allottees or not as agreed in the BBA signed between the parties.

During the course of arguments, the counsel for the respondent argued upon the fact that the assured return payable to the complainant as promised in the BBA signed between them is illegal now according to BUDS, Act 2019 therefore the respondent is not liable to pay the assured sum as agreed before. The definition of "deposit" as defined under BUDS, Act 2019 and in Company Act, 2013 were also compared at length. The written submissions w.r.t the same was also submitted by the counsel and the same were placed on record for the kind perusal of the Authority.
