## Proceedings through VC

The JD has paid a sum of Rs. 55,06,280/- on different dates against the total payment of Rs. 61,06,997/- (inclusive interest). As per calculation sheet of the CA of the authority, the remaining amount due is Rs.6,00,697/-. The counsel for the JD has raised certain objections to the decretal amount. Consequently, both the parties were directed on last date of hearing i.e., 27.01.2022 to re-appear before the CA of the authority to finalize/reverification of the decretal amount. But no one appeared before the CA of the authority to clarify the issue.

The JD has further paid an amount of **Rs.4,17,214**/- vide cheque bearing no. 001437 with HDFC bank on 27.01.2022 to be paid to the decree holder. The registry is directed to handover the said cheque to the decree holder.
