ORDER (RAJAN GUPTA-CHAIRMAN)

1. Both parties have concluded their arguments. Authority has completed the proceedings and is ready to pronounce final order. However, an order dated 22.02.2022 passed by Hon'ble Appellate Tribunal has been placed before Authority by Sh. Venket Rao, learned counsel for the respondent. The orders passed by Hon'ble Appellate Tribunal reads as follows:

"... Issue notice of the present appeal as well as stay application to the respondent for 28th March, 2022 on filing

In the meanwhile, the Ld. Authority may continue with the proceedings of the complaint, but will not pronounce the final order."

- 2. In view of the concluded arguments, Authority has decided to dispose of all the complaints and decides not to pronounce its final order in view of the order passed by Hon'ble Appellate Tribunal. The Authority further decides to keep its judgment in sealed cover. Appropriate action will be taken by Authority on the judgment put in sealed cover upon receiving final order of Hon'ble Appellate Tribunal in Appeals No. 631, 632, 633, 634, 635, 636, 637, 638, 639 and 640 of 2021.
- 3. <u>Disposed of</u>. The matters will be taken up for pronouncement or appropriate action in accordance with order of Hon'ble Appellate Tribunal. This order be uploaded on website of Authority and files be consigned to record room.
