Senior Town Planner; Gurugram vide his memo no. 3529 dated 23.09.2020 confirmed about laying or the colony as per approved Building plans. SE,HVPNL vide their office memo dated 77.05.2022have recommended the grant of completion certificate.

In view of these reports it is hereby certified that the required development works in the said commercial colony over an area measuring 4.44 acres as indicated on the enclosed plans duly signed by me read in conjunction with the following terms and conditions have been completed to my satisfaction. The development works are water supply, sewerage, storm water drainage; roads, horticulture & electrification etc. The completion certificate is granted on the following terms and conditions:-

The services will be laid by you upto alignment of proposed external services of the town and connection with the GMDA system will be done with the prior approval of the competent authority. In case pumping is required; the same will be done by you at your own cost. The services will be provided as perprovision mather EDC of Gurugram.

Inat you shall be solely responsible for making arrangement of water supply and discessal of sewage and storm water of colony as per requirement/guidelines of HSPCB/Environment Department till such time, the external services are provided by HSVP/State Government as per their scheme. Level/tixtent of the services to be provided by GMDA i.e. water supply sewerage, SWD, roads etc. will be proportionate of EDC provisions.

That you shall maintain a roof top rain water harvesting system properly and mail keep a operational all the time.

That in case some additional structures are required to be constructed and decided by GMDA at a later stage, the same will be binding upon you. How

control valves will be installed, preferably of automatic type on water supply connection with GMDA water supply line.

- That the NSL formation level of roads have been verified and are correct. You shall be responsible in case of any mistake in levels etc.
- Hiat you shall be fully responsible for operation, upkeep and maintenance of all roads, open spaces, public parks and public health services like water supply, sewerage and drainage etc. for a period as approved in the service planestimates of your colony from the date of issuance of final completion certificate or earlier relieved of said responsibility and thereupon transfer all such roads open spaces, public parks and public health services like water supply, sewerage and drainage etc. free of cost to the Government or the Local Authority as directed
- 11 That you shall neither erect nor allow the erection of any communication and transmission Tower with jn colony without prior approval of competent authority.
- That you shall comply with the conditions of Service Plan/Estimates approved by the Department vide memo dated 08.03.2019 and the conditions imposed by
- That you shall abide by all prevailing norms/rules and regulations as fixed by GMDA.
 - That Bank Guarantee equivalent to 1/5th amount of the BG deposited on account on IDW having validity of minimum 5 years shall be deposited to ensure upkeep and maintenance of the colony as per Rule 20 of Rules 1976.
 - That you shall comply with the terms and conditions as approved from the concerned power utility.
- Hint you shall submit mutation for the land transferred in favour of the Govt. within 30 days of issuance of this completion certificate.

This completion certificate shall be void ab initio, if any of the infittions mentioned above are not complied with and this approval will not provide as y unimimity from any other Act/Eples/Regulations applicable to the land in question.
