

(i) The promoter shall submit the copy of occupation certificate, copy of OC application and attached documents,

namely: -

- deed of declaration and enclosed documents; (ii) The promoter shall offer to execute and
- register a conveyance deed in favour of the allotee(s) for Unit/Apartment for Residential/Commercial/any other usage (as the case may be) along with parking (if applicable);
