(ii)	The promoter shall comply with the requirement of section 4(2)(l)(D) and get h accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified an signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for that project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project. All such pending compliances after coming into force of the Real Esta (Regulation and Development) Act, 2016 shall be submitted to the authority with three months.	
(iii)	The promoter undertakes and ensures that it will complete the project in all sincerity having sufficient resources to complete the construction of this part of the project by the date as specified in the DPI and to complete the whole project within the time declared in DPI.
