

The promoter shall comply with the requirement of section 11(1) and submit the (xx)quarterly up-to-date status of the project for each quarter. The promoter shall complete the construction of community sites within the (xxi) completion period declared under section 4(2)(l)(C) of the Act, 2016 and any failure would attract stringent action and penal proceedings. The authority reserves its right to initiate penal proceedings for violation of various (xxii) provisions of the Real Estate (Regulation & Development) Act, 2016 and rules and regulations made thereunder. The promoter has deposited the penalty amount of Rs 25 lakhs vide DD no. 000812 dated 27.06.2025 before issuance of this certificate to permit registration of this part of the project to remain in force. (ii) The promoter shall comply with the requirement of section 4(2)(1)(D) and get his accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for that project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project. All such pending compliances after coming into force of the Real Estate (Regulation and Development) Act, 2016 shall be submitted to the authority within three months. (iii) The promoter undertakes and ensures that it will complete the project in all sincerity having sufficient resources to complete the construction of this part of the project by the date as specified in the DPI and to complete the whole project within the time declared in DPI. The promoter shall execute work as per the schedule submitted by him and milestones to be achieved as declared to the authority.
