The promoter shall comply with the requirement of section 11(1) and submit the (xx) quarterly up-to-date status of the project for each quarter. The promoter shall complete the construction of community sites within the (xxi) completion period declared under section 4(2)(l)(C) of the Act, 2016 and any failure would attract stringent action and penal proceedings. The authority reserves its right to initiate penal proceedings for violation of various (xxii) provisions of the Real Estate (Regulation & Development) Act, 2016 and rules and regulations made thereunder.
