

This extension of registration is granted subject to the following conditions, namely: -

(i) The promoter shall submit the renewal of license, revalidated building plan approval, REP-1(A to H) online application form, detailed project information and details of all three accounts- Master Account, Separate RERA compliant account, Free account within two months from issuance of this certificate;

- (ii) The promoter shall submit the copy of occupation certificate, copy of OC application and attached documents, deed of declaration and enclosed documents:
- (iii) The promoter shall offer to execute and register a conveyance deed in favour of the allotee(s) for Unit/Apartment for Residential/Commercial/any other usage (as the case may be) along with parking (if applicable);
- (iv) If there is any increase in the taxes/charges/fees/levies etc. after the expiry of the scheduled date of completion of the project as per registration with the authority, which shall include the extension of the registration if any, granted to the said project by the authority, as per the Act, the same shall not be charged from the allottees;
