- (iv) The promoter undertakes and ensures that it will complete the project in all sincerity having sufficient resources to complete the construction of this part of the project by the date as specified in the DPI and to complete the whole project within the time declared in DPI. The promoter shall execute work as per the schedule submitted by him and milestones to be achieved as declared to the authority.
- (v) The promoter had declared the completion period of the entire project by 31.12.2023, and few of the licenses/approvals would be expired within the time declared for completion of the project. Further, the promoter is directed to take various approvals/renewals whenever due within the time, from the competent authorities. Any failure in this regard will invite stringent action as per the provision of the law against the promoter.
