(E) VALIDITY OF REGISTRATION

The earlier registration certificate having number 348 of 2017 was valid from 09th November 2017. Now, the amended registration of the project shall be valid for the **period commencing from 05th December, 2022 and ending with 28th August, 2024** (completion date as declared by the promoter in REP-II) unless extended by the Authority in accordance with the Act and rules made thereunder subject to compliance of provisions of rule 5(1) of the Haryana Real Estate (Regulation and Development) Rules, 2017. The completion date of the project is kept same as per the earlier registration certificate.

This guaranteed amount shall be forfeited in case, the respective condition is not fulfilled by the promoter within the stipulated time period mentioned in the conditions.
(iii)	The promoter shall comply with the requirement of section 4(2)(1)(D) and get his accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for that project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
