#### (E) VALIDITY OF REGISTRATION


The registration of this project shall be valid for the **period commencing from 06th January 2020 and ending with 31st December 2023** (completion date as declared by the promoter in REP-II) unless extended by the Authority in accordance with the Act and rules made thereunder subject to compliance of provisions of rule 5(1) of the Haryana Real Estate (Regulation and Development) Rules, 2017. There is no change in the completion date of the project.

This registration certificate is based on the information supplied by the promoter and an authenticated detailed project information (DPI) and declaration by the promoter is annexed herewith, which shall be read as part of this registration certificate.

#### (F) CONDITIONS OF REGISTRATION

### 2. This registration is granted subject to the following conditions, namely:





In case of introduction of new real estate agent or change/deletion of real estate agent as mentioned in the DPI, the promoter shall inform the same to the authority. (xii) There shall not be any subvention scheme/ assured returned scheme for the registered project without prior approval of the authority. (xiii) The promoter at the time of booking and issue of allotment letter shall be responsible to make available to the allottee, the following information, namely-(a) Sanction plan, layout plans along with specification, approved by the competent authority, by display at the site or such other place as may be specified by the regulations made by the authority. (b) The stage wise time schedule of completion of the project including the provisions for civic infrastructure like water, sanitation and electricity. The promoter shall declare details of the unit along with specifications, payment plan and time for handing over of possession of unit after obtaining all required approvals from the competent authority. As per section 13(1), the promoter shall not accept a sum more than ten per cent of the cost of the apartment, plot, or building as the case may be, as an advance payment or an application fee, from a person without first entering into a written agreement for sale as prescribed with such person and register the said agreement for sale, under any law for the time being in force. The promoter is obligated to take various approval/renewals whenever due on (xix) time, from the competent authorities. Any failure in this regard will invite stringent action as per the provision of the law against the promoter. The promoter shall comply with the requirement of section 11(1) and submit (XX) the quarterly up-to-date status of the project for each quarter. The promoter shall complete the construction of community sites within the (xxi) completion period declared under section 4(2)(1)(C) of the Act, 2016 and any failure would attract stringent action and penal proceedings. (xxii) The authority reserves its right to initiate penal proceedings for violation of various provisions of the Real Estate (Regulation & Development) Act, 2016 and rules and regulations made thereunder. (G) COMPLIANCES TO BE MADE BY THE PROMOTER (i) While issuing the earlier RC (RC/REP/HARERA/GGM/386/118/2020/02 dated 06.01.2020) for an area measuring 4.73125 Acres, the promoter had to submit the copy of environmental clearance, fire scheme and approved service plan and estimates within a period of 3 months. Now, the promoter has applied for additional area of 0.3247 acres and the application is taken for whole area i.e., 5.05595 acres, the promoter has submitted the environmental clearance, fire scheme approval and shall submit the approved revised service plans and estimates within 3 months from the date of grant of registration. (ii) In case of failure to submit the copies of approved revised service plans and estimates within three months from the date of grant of registration, the amount collected from the allottees will be refunded with interest at the prescribed rate within one month thereafter and the registration certificate shall be treated as deemed cancelled. (iii) The promoter shall comply with the requirement of section 4(2)(1)(D) and get his accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for that project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project. All such pending compliances after coming into force of the Real









Estate (Regulation and Development) Act, 2016 shall be submitted in the authority within a period of three months.

- (iv) The promoter is directed to clear the title of the project land from any litigations before the offer of possession and if due to the above litigation, any allottee gets the defective title of land and in case of any loss caused to him due to defective title of the land then the allottee would be entitled to get compensation as provided in section 18(2) of the Act.
- 3. If the above-mentioned conditions are not fulfilled/ compliances are not made by the promoter, the Authority may take necessary action against the promoter including revoking the registration granted therein, as per the Act and the rules and regulations made thereunder.




