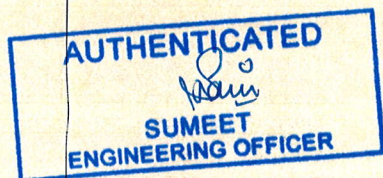
**CONDITIONS OF EXTENSION OF
