Subject: Recruitment of six Law Associates in HRERA, Panchkula.

The Selection Committee comprising of Hon'ble Chairman, Hon'ble Member, ED and JC (B&A) has conducted interview for the post of Law Associates on 27.12.2021 and 28.12.2021. 29 shortlisted candidates of the following categories were called for interaction with the Selection Committee.

2. Out of these 29 applicants, 26 applicants attended the interview. Three applicants (General – 01, BCA – 01, BCB – 01) did not attend the interview. The Selection Committee recommended as under:
