Steps to be followed by the Complainant for filing of Complaints for Execution of the orders of the Authority/ Adjudicating Officer, HRERA as the case may be:

- The complainant should register complaint for execution of orders on the website of the Authority before filing the same before the Authority or Adjudication Officer, as the case may be.
- ii. The complainant is advised to follow the detailed procedure for registration and filing of complaints as mentioned in the Haryana Real Estate Regulatory Authority, Panchkula (Adjudication of Complaints) Regulations, 2018.
- iii. The complainant is required to remit the prescribed fee through the online process; till the online payment gateway becomes operational, the complainant may submit demand draft of the prescribed fee along with copies in triplicate of the complaint with the Authority.
- iv. The complainant is required to file hard copy of the complaint (3 nos.) along with Proforma-B in the Receipt Section of the Authority within 30 days of generating Proforma-B.

  Adjudicating Officer is placed at 'Appendix-I'.
