It is for the information of the general public that an application dated 13.08.2026 for registration of the project under Section 4 of the Act of 2016 is submitted in the Authority for the project “**M9 Square**”.

The Department of Town & Country Planning, Haryana granted license no. 136 of 2022 dated 08.09.2022 to M/s Active Promoters Pvt. Ltd. and others in collaboration with M/s Worldwide Resorts and Entertainment Pvt. Ltd. for the development of Industrial Plotted Colony on area measuring 118.15 acres in Sector- M-9, M-10, M-13, M-14, Manesar, Gurugram.

The Industrial Plotted Colony has been registered with the Authority vide RC no. 100 of 2022 dated 14.11.2022 which was valid upto 30.09.2024. Further, extended vide Extension no. 13 of 2025 dated 20.03.2025 which was valid upto 30.09.2025. Further, continued vide Continuation no. 34 of 2025 dated 01.12.2025 which is valid upto 29.09.2027.

Now, the Senior Town Planner cum Chairman of Building Plan Approval Committee, Gurugram, Haryana, has approved the building plans for a Commercial-4 project over 882.28 sqm in Sector Sector- M-9, M-10, M-13, M-14, Manesar, Gurugram, vide Memo no. 3383 dated 22.06.2026, valid upto 21.06.2028. The promoter has now approached the Haryana Real Estate Regulatory Authority, Gurugram, for the registration of the project.

The current application dated 13.08.2026 for registration pertains to Distinct Commercial Component (Commercial – 4 admeasuring 882.28 sq mt) of the above licensed Industrial Plotted Colony measuring 118.15 acres namely “**The Golden City**”.
