Dear Sir/Ma'am,

We, Capri Global Housing Finance Limited, a company incorporated under the provisions of the Companies Act, 1956 and registered with the Reserve Bank of India as Housing Finance Company and regulated by National Housing Bank / Reserve Bank of India and having its registered office at 502, Tower A, Peninsula Business Park, Senapati Bapat Marg, Lower Parel, Mumbai – 400 013, (hereinafter referred to as "CGHFL"). We further state that, JMS Realty Developers LLP having PAN: AAVFJ3844L with its Registered office at Plot No. 2380-SP, Sector-46, Khandsa Road, Gurgaon, Haryana-122001 ("Borrower") had availed financial assistance from CGHFL for the purpose of acquisition of security plots, construction and development of the security plots. In order to secure the said financial assistance, Borrower has created first and exclusively charge/mortgaged over the mortgaged properties (as specified in Schedule I) through Memorandum of Deposit of Title Deeds (Mortgage Deed) dt. 22-April-2025 & DOH dt. 22-April-2025

As per the terms and conditions of General Terms and Conditions Agreement dt. 24-March-25 read with Schedule of Terms dt.24-March-25, Borrower is required to obtain NOC/consent from Lender for sale/transfer of any units/flats/shops of Project "JMS Group The Majestic Abode" and deposit all the receivables with respect to the units/flats in the Designated Escrow Account of Project as per agreed terms of Escrow Agreement dt. 24-March-25. Once the entire receivables with respect to the units are deposited in Designated Escrow Account, CGHFL charge/mortgaged shall stand released from the respective units. The Consent Letter is subject to the Borrower acquiring all requisite approvals, permissions and complying with all applicable provisions under the Borrower's constitutional documents and all statutory provisions or otherwise. In case, of any such non-compliance or default, this Consent Letter shall stand withdrawn with retrospective effect and, without prejudice to any other right available to us under law, the Borrower shall indemnify and keep us indemnity against any loss, damage, charges, cost or expenses, including all legal cost, that we may incur due to the Proposed Transaction and/or any non-compliance or default committed thereunder.

We had got requested letter / mail from Borrower dt. 05th September 2025, requesting CGHFL to issued consent letter/No objection in the favor of Haryana Real Estate Regulatory Authority in relation to mortgaged properties/flats/Units shall stand released on receipt of entire sale consideration by homebuyers of respective flats/units in Designated Escrow Account of Project.

Basis on request letter submitted by Borrower, we, the Lender, hereby confirm that:

1. The Borrower is under an obligation to seek no objection from us, in respect of the sale/transfer of any Unit at the time of execution of agreement for sale/transfer in respect of such Unit. Subject to the deposit of the entire sale considerations in the master collection account.
2. Once the purchaser of any Unit in the Borrower Project "JMS Group The Majestic Abode" has deposited the entire sale proceeds pertaining to such Unit in the Borrower Project "JMS Group The Majestic Abode" into the Master Escrow Account opened in respect of the Borrower Project "JMS Group The Majestic Abode", the Allottee/ Purchaser shall not be liable towards Loan outstanding against the Borrower Project "JMS Group The Majestic Abode" or Borrower, and Borrower will be entitled to execute the necessary Conveyance Deed for Sale of the particular Unit in favour of the Allottee/Purchaser without any further permission of the Lender.



3. Upon the Occurrence of the Event of Default under the Escrow Agreement, we will not object to or restrict the ability of Borrower to Execute the necessary Conveyance Deed for sale of the particular Unit in favour of the Allottee/Purchaser of Borrower Project "JMS Group The Majestic Abode", provided that the purchaser of any Unit in the Borrower Project "JMS Group The Majestic Abode" has deposited the entire sale proceeds (as per relevant Agreement to Sell/Builder Buyer Agreement executed with such Allottee) pertaining to such Unit.

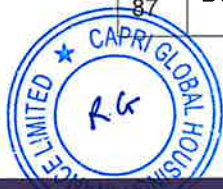
