**Affidavit cum Declaration**

Affidavit cum Declaration of Mr. Bharat Vigmal on behalf of M/s M3M India Infrastructures Private Limited ("**Company**") (CIN#U45400HR2014PTC054057) having its registered office at 41st Floor, Tower-1, M3M International Financial Center, Sector-66, Badshahpur, Gurgaon is under the process of development of a Group Housing project forming Pocket B namely "**M3M FORESTIA EAST I**" proposed to be developed over an area admeasuring 6.460 acres being a part of larger land parcel admeasuring 9.1521 acres as per the terms and conditions of licence no 168 of 2025 dated 08.09.2025 granted in respect of land admeasuring 139.79375 acres situated at Village Bas Haria and Jhund Sarai Abad, Sector-M9, M10 and M11 Manesar, Gurugram, Haryana duly authorized by the promoter of the proposed project, vide its authorization dated 06.11.2025.

I, Mr. Bharat Vigmal duly authorized by the promoter of the proposed project do hereby solemnly declare, undertake and state as per the facts and documents provided by the promoter as under:

1. The promoter has the legal title to the land on which the development of the proposed project is to be carried out.

Explanation.—where the promoter is not the owner of the land on which development of project is proposed, details of the consent of the owner of the land along with a copy of the registered (wherever applicable) collaboration agreement, development agreement, joint development agreement or any other agreement, as the case may be, entered into between the promoter(s) and such owner and copies of title and other documents reflecting the title of such owner on the land on which project is proposed to be developed.

2. That the said land is free from all encumbrances.
3. That the promoter shall obtain the Occupation Certificate (OC) on or before 30.06.2034 and Completion Certificate (CC) on or before 31.12.2034.



4. That seventy per cent of the amounts realized by promoter for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
5. That the amounts from the separate account, to cover the cost of the project, shall be withdrawn by the promoter in proportion to the percentage of completion of the project.
6. That the amounts from the separate account shall be withdrawn the promoter after it is certified by an engineer, an architect and a chartered accountant in practice that the withdrawal is in proportion to the percentage of completion of the project.
7. That the promoter shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.
8. That the promoter shall take all the pending approvals on time, from the competent authorities.
9. That the promoter has furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.
10. That the promoter shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on the grounds of sex, cast, creed, religion etc.
