This License has been granted under the Haryana Development and Regulation of Urban Areas Act 1975 & the Rules 1976 made there under to Advitya Residency LLP, Regd. Office: 202, 2nd Floor, Vikramaditya Tower, Alkananda Market, Kalkaji New Delhi-110019, Email ID:- advityaresidency@gmail.com for setting up of an Affordable Group Housing Colony over an additional area measuring 3.04375 acres (in addition to licence no. 127 of 2019) falling in the revenue estate of village-Sikri, Sector-143, Tehsil-Ballabgarh, District Faridabad, Haryana.

1. The particulars of the land, wherein the aforesaid Affordable Group Housing colony is to be set up, are given in the Schedule annexed hereto and duly signed by the Director, Town & Country Planning, Haryana.
2. The Licence is granted subject to the following conditions:-
 - i. That the Affordable Group Housing Colony will be laid out in confirmation to the approved building plan and development works will be executed in accordance to the designs and specifications shown in the approved plans.
 - ii. That the conditions of the agreements already executed are duly fulfilled and the provisions of the Haryana Development and Regulation of Urban Areas Act, 1975 and Rules 1976 made thereunder are duly complied with.
 - iii. That area coming under the sector roads and restricted belt / green belt, if any, which forms part of licensed area and in lieu of which benefit to the extent permissible as per policy towards FAR is being granted, shall be transferred to the Govt. within a period of 30 days from grant of licence/approval of zoning plan.
 - iv. That licensee shall maintain and upkeep of all roads, open spaces, public park and public health services for a period of five years from the date of issue of the completion certificate unless earlier relieved of this responsibility and thereupon to transfer all such roads, open spaces, public parks and public health services free of cost to the Govt. or the local authority, as the case may be, in accordance with the provisions of Section 3(3)(a)(iii) of the Haryana Development and Regulation of Urban Areas Act, 1975.
 - v. That licensee shall construct portion of internal circulation roads, forming the part of site area at your own cost and shall transfer the land falling within alignment of same to the Govt. within a period of 30 days from grant of licence/approval of zoning plan.
 - vi. That licensee shall be liable to pay the actual rates of External Development Charges as and when determined and demanded as per prescribed schedule by the DTCP Haryana.
 - vii. That licensee shall construct the community building at your own cost, or get constructed by any other institution or individual at its costs, the community building on the lands set apart for this purpose, as per provisions of section 3(3)(a)(iv) of Haryana Development and Regulation of Urban Areas Act, 1975.
 - viii. That licensee shall integrate the services with Haryana Shehri Vikas Pradhikaran services / Faridabad Metropolitan Development Authority as and when made available.
 - ix. That licensee have understood that the development/construction cost of 24 m/18 m major internal roads is not included in the EDC rates and you shall pay the proportionate cost for acquisition of land, if any, alongwith the construction cost of 24 m/18 m wide major internal roads as and when finalized and demanded by the Department.
 - x. That licensee shall obtain NOC/Clearance as per provisions of notification dated 14.09.2006 issued by Ministry of Environment & Forest, Govt. of India before execution of development works at site.

- xi. That licensee shall make arrangements for water supply, sewerage, drainage etc. to the satisfaction of DTCP till these services are made available from External Infrastructure to be laid by Haryana Sehari Vikas Pradhikaran / Faridabad Metropolitan Development Authority.
- xii. That the rain water harvesting system shall be provided as per Central Ground Water Authority Norms/Haryana Govt. notification as applicable.
- xiii. That licensee shall make provision of solar water heating system as per guidelines of Haryana Renewable Energy Development Agency and shall make operational where applicable before applying for an Occupation Certificate.
- xiv. That licensee shall use only LED fitting for internal lighting as well as campus lighting.
- xv. That licensee shall convey the 'Ultimate Power Load Requirement' of the project to the concerned power utility, with a copy to the Director, within two months period from the date of grant of license to enable provision of site in licensed land for Transformers/Switching Stations/Electric Sub-stations as per the norms prescribed by the power utility in the zoning plan of the project.
- xvi. That licensee shall get the electrification plan approved from the competent authority of DISCOM and will submit the same before approval of building plan.
- xvii. That licensee shall get the NOC from competent authority of DISCOM before grant of occupation certificate / part completion certificate / completion certificate in compliance of notification dated 03.10.2023 issued by HERC the developer.
- xviii. That licensee shall submit compliance of Rule 24, 26, 27 & 28 of Rules 1976 & Section 5 of Haryana Development and Regulation of Urban Areas Act, 1975, and shall inform account number and full particulars of the scheduled bank wherein licensee have to deposit the amount received from the flat holders for meeting the cost of Internal Development Works in the colony.
- xix. That licensee shall permit the Director or any other office authorized by him to inspect the execution of the layout and the development works in the colony and to carry out all directions issued by him for ensuring due compliance of the execution of the layout and development works in accordance with the license granted.
- xx. That licensee shall deposit seventy per centum of the amount release, from time to time, by you, from the flat owner within a period of ten days of its realization in a separate account to be maintained in a scheduled bank. This amount shall only be utilized by you towards meeting the cost of internal development works in the colony.
- xxi. That licensee shall not give any advertisement for sale of commercial area and flat in Affordable Group Housing project before the approval of building plans of the same.
- xxii. That licensee shall pay the labour cess as per policy instructions issued by Haryana Government vide Memo No. Misc. 2057-5/25/2008/2TCP dated 25.02.2010.
- xxiii. That licensee shall keep pace of construction atleast in accordance with sale agreement executed with the buyers of the flats as and when scheme is launched.
- xxiv. That licensee shall obtain clearance from competent authority that the land is not affected by section 4 & 5 of the PLPA, 1990 and other forest laws.
- xxv. That licensee shall obey all the directions/instruction given by this department time to time in public interest.
- xxvi. That licensee shall strictly comply with the directions issued vide notification No. 19/6/2016-5P dated 31.03.2016 issued by Haryana Government Renewable Energy Department for enforcement of the Energy/ Conservation building codes.
- xxvii. That licensee shall ensure the installation of solar photovoltaic power plant as per the provisions of order No. 22/52/2005-5 Power dated 21.03.2016 issued by Haryana Government Renewable Energy Department.
- xxviii. That licensee shall abide by the terms and conditions as per Affordable Housing Policy-2013 notified on 19.08.2013 and its subsequent amendments.

- xxix. That the provisions of the Real Estate (Regulation and Development) Act, 2016 and rules framed thereunder shall be followed by the applicant in letter and spirit.
- xxx. That licensee shall abide by the terms and conditions of the access permission issued by HSVP, Panchkula.
- xxxi. That the licensee shall get the electrification plan approved from the competent authority of DISCOM and shall submit the same before approval of building plan.
- xxxii. That licensee shall execute the development works as per Environmental Clearance and comply with the provisions of Environment Protection Act, 1986, Air (Prevention and Control of Pollution of Act, 1981) and Water (Prevention and Control of Pollution of 1974). In case of any violation of the provisions of said statutes, you shall be liable for penal action by Haryana State Pollution Control Board or any other Authority Administering the said Acts.
3. The licence is valid up to 16-04-2030.
