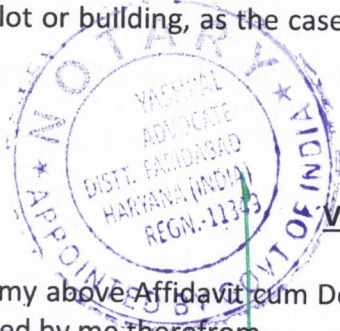
1. That the promoter has a legal title to the land on which the development of the project is proposed.
