Affidavit cum Declaration

Affidavit cum Declaration of **Mr. Nisarg Trehan S/o Mr. Harsh Trehan** promoter of the **TREHAN VALLEY** (Project) duly authorized by the **M/s TREHAN HOSPITALITY AND REALITY PRIVATE LIMITED** promoter of the proposed project, vide their authorization dated 08-11-2024.

I, **Nisarg Trehan** do hereby solemnly declare, undertake and state as under:

1. That **M/s Trehan Hospitality and Reality Pvt. Ltd.** have a legal title to the 27 plots at **MKS County Sector-2 Sohna Gurgaon, Haryana** on which the development of the proposed project is to be carried out.

2. That the said land is free from all encumbrances.

3. That the time period within which the project shall be completed by **M/s TREHAN HOSPITALITY AND REALITY PRIVATE LIMITED** on 27 plots is 08-11-2027.

4. That seventy per cent of the amounts realised by **M/s TREHAN HOSPITALITY AND REALITY PRIVATE LIMITED** for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.

7. That **M/s TREHAN HOSPITALITY AND REALITY PRIVATE LIMITED** shall get the accounts audited within six months after the end of every financial year by a chartered accountant in practice, and shall produce a statement of accounts duly certified and signed by such chartered accountant and it shall be verified during the audit that the amounts collected for a particular project have been utilized for the project and the withdrawal has been in compliance with the proportion to the percentage of completion of the project.

8. That **M/s TREHAN HOSPITALITY AND REALITY PRIVATE LIMITED** shall take all the pending approvals on time from the competent authorities.

9. That **M/s TREHAN HOSPITALITY AND REALITY PRIVATE LIMITED** have furnished such other documents as have been prescribed by the Act and the rules and regulations made thereunder.

10. That **M/s TREHAN HOSPITALITY AND REALITY PRIVATE LIMITED** shall not discriminate against any allottee at the time of allotment of any apartment, plot or building, as the case may be, on the grounds of sex, cast, creed, religion etc.
