PROJECT DETAILS

M/s Ashiana Housing Limited ("**Promoter**") is the absolute owner and is seized and possessed of and otherwise well and sufficiently entitled to the freehold property admeasuring approximately 10.80 acres situated at IMT Manesar Sector 80, District Gurgaon, Haryana ("**Entire Land**"). The Entire Land was purchased *vide* Conveyance Deed dated 07.10.2024 registered before Sub Registrar, Manesar, Gurugram.

The department of HSIDC has the land *vide* Regular letter of Allotment Without Offer of Possession bearing ref No.221 dated 01.08.2023 in favour of Ashiana Housing Ltd. The Conveyance Deed was executed by HSIIDC and Ashiana *vide* Document No.9168 dated 07.10.2024. Possession certificate dated 05.09.2024 was issued by HSIIDC.

The Entire Land is earmarked for the purpose of building a residential project, comprising of multistoried apartments, buildings, permissible commercials, nursery school/learning hub etc. Accordingly, the Promoter was granted permission for construction and development of group housing project by HSIIDC *vide* Memo No.HSIIDC/IPD/IMT/M/2025/1050. Dated-08.10.2025 ("**Whole Project**") with clear demarcation of the phases.

The Promoter being in possession of the Entire Land is developing a residential project to be known as "**Ashiana Aaroham**" on 10.80 acres of land being part and parcel of the Entire Land ("**Said Land**"). The Whole Project developed/ to be developed on the Entire Land shall be called "**Ashiana Aaroham**". However, for convenience and ease of construction, sales and marketing, the Whole Project "**Ashiana Aaroham**" has been divided into various phases and proposed to be developed in a phase wise manner with the clear intent to integrate all phases into one upon completion of the Whole Project. The Promoter is in the process of constructing and developing one of the phases of the Whole Project on 43,708 sqm. of land forming part of the Said Land and the said phase shall be known as **Ashiana Aaroham Phase I**.

The Promoter declares that Land cost of Aaroham Phase I is **Rs 7,310.53.00** Ashiana Aaroham Phase I shall incur a total construction cost of **Rs.27,627.71.00** [Tower wise Cost of Construction (**Rs. 11047.02.00** + Cost of Development Work (**Rs. 2134.69.00**) + Other Costs (**Rs.7135.20.00**)] A bifurcation of the construction cost as per towers and quarters is given below:
