We, Mr. Rajesh Kumar Sharma S/o Sh. B.D. Sharma and Mr. Ravinder Kumar S/o Sh. Mool Chand do hereby solemnly declare, undertake and state as under:

- That a legally valid authentication of title of such land along with an authenticated copy of the agreement between such owner and promoter for development of the real estate project is enclosed herewith.
- That the said land is free from all encumbrances.
- That the time period within which the project shall be completed by promoter is inthe 10. months
- That seventy per cent of the amounts realised by promoter for the real estate project from the
