1. That <u>M/s Era Resorts Pvt. Ltd.</u> has a legal title to the land on which the development of the proposed project is to be carried out

2. That the said land is free from all encumbrances.

3. That the time period within which the project shall be completed by M/s Era Resorts Pvt Ltd. is <u>Three</u> <u>Year</u> from the date of this affidavit.

4. That seventy per cent of the amounts realised by M/s Era Resorts Pvt Ltd. for the real estate project from the Allottees, from time to time, shall be deposited in a separate account to be maintained in a scheduled bank to cover the cost of construction and the land cost and shall be used only for that purpose.
