 - d) That licencee shall maintain and upkeep all roads, open spaces, public parks and public health services for a period of five years from the date of issue of the completion certificate unless earlier relieved of this responsibility and thereupon to transfer all such roads, open spaces, public parks and public health services free of cost to the Govt. or the local Authority, as the case may be in accordable with the provisions of Section 3(3)(a)(iii) of the Haryana Development and Regulation of Urban Areas Rules, 1976.
 - e) That licensee shall integrate the services with HUDA services as per approved service plans and as & when made available.
 - f) That licensee shall construct their own cost, or get constructed by any other institution or individual at its costs, schools, hospitals, community centers and other community buildings on the land set apart for this purpose, within four years form grant of licence extendable by the Director for another period of two years, for the reasons to be recorded in writing failing which the land shall vests with the Government after such specify period, free of cost, in which case the Government shall be at liberty to transfer such land to any person or any intuition including a local Authority, for the said purposes, on such terms and conditions, as it may deem fit.
 - g) That licensee shall make arrangements for water supply, sewerage, drainage etc. to the satisfaction of DG, TCP till these services are made available from External Infrastructure to be laid by HUDA/HSIIDC.
 - h) That licencee understand that development/construction cost of 24/18 m wide major internal roads is not included in the EDC rates and licencee shall pay the proportionate cost for acquisition of land, if any, alongwith the construction cost of the same as and when finalized and demanded by DGTCP, Haryana.
 - i) That licensee shall submit NOC as required under notification dated 14.09.06 issued by Ministry of Environment and Forest, Govt. of India before actual execution of development works at site.
 - j) That licensee shall obtain clearance from competent Authority, if required under PLPA, 1900 and any other clearance required under any other law.

- k) That licensee shall pay the labour cess charges as per policy dated 4.5.2010.
- I) That licensee shall provide rain water harvesting system at site as per guidelines/ notification/norms of Central Ground Water Authority norms/Haryana Govt., as applicable.
- m) That licensee shall make the provision of solar water heating system as per recommendations of HAREDA and shall make it operational, where applicable, before applying for Occupation Certificate.
- n) That licensee shall use only CFL fittings for internal as well as for campus lighting.
- o) That in compliance of Rule 27 of Rules 1976 & Section 5 of Haryana Development and Regulation of Urban Areas Act, 1975, licencee shall inform account number and full particulars of the scheduled bank wherein licencee have to deposit thirty percentum of the amount from the flat holders for meeting the cost of internal development works in the colony.
- p) That at the time of booking of the residential/commercial spaces in the licenced colony, if the specified rates of residential/commercial spaces do not include IDC/EDC rates and are to be charged separately as per rates fixed by the government from the plots/flats/commercial spaces owners, licencee shall also provide details of calculations per Sqm/per Sq ft to the allottee while raising such demand of EDC.
- q) That licencee shall keep pace of construction atleast in accordance with their (licensee) sale agreement with the buyers of the flats/shops as and when scheme is launched, after approval of building plans.
- r) That licence shall shift the 66 KV HT line underground at their cost in consultation with HVPNL.
- s) That licencee shall not create third party rights/pre launch before approval of building plans.
- t) That licencee shall obey all the directions/restriction given by this Department from time to time in public interest.
- u) That provision of External Development Facilities may take long time by HUDA, the Applicant Company shall not claim any damages against the Department for loss occurred if any.
