LICENCE NO. 82 OF 2014

This License has been granted under the Haryana Development and Regulation of Urban Areas Act, 1975 & the Rules, 1976 made thereunder to Smt. Kiran W/o Sh. Dhapam and Sunrays Heights Pvt. Ltd., C/o 211, Ansal Bhawan 16 K.G. Marg, New Delhi-110001 for development of Affordable Group Housing Colony over an area measuring 5.9 acres in the revenue estate of village Ullahwas, District Gurgaon, Sector-63-A of Gurgaon-Manesar Urban Complex.

2. The particulars of the land, wherein the aforesaid Affordable Group Housing Colony is to be set up, are given in the Schedule (duly signed) annexed hereto.
3. The License is granted subject to the following conditions:-
 - a) That licensee shall follow the terms and conditions in respect of policy issued vide memo no PF-27/48921 dated 19.08.2013 for Affordable Group Housing Colony.
 - b) That the portion of Sector/Development plan road which shall form part of the licensed area shall be transferred free of cost to the Government/HUDA in accordance with the provisions of Section 3(3) (a) (iii) of the Haryana Development and Regulation of Urban Areas Act, 1975 within one month from date of issue of licence under intimation to this office.
 - c) That licensee shall lay out the Affordable Group Housing Colony in confirmation to the approved layout/Building plans and development works are executed according to the designs and specifications shown in the approved plans.
 - d) That licensee shall submit additional bank guarantee, if any, required at the time of approval of Service Plans/Estimate. With an increase in the cost of construction and increase in the number of facilities in Building Plans, you would be required to furnish an additional bank guarantee within 30 days on demand. It is made clear that bank guarantee of Internal Development Works/EDC has been worked out on the interim rates.
 - e) That licensee shall comply with the conditions of the agreement already executed and the provisions of Haryana Development and Regulation of Urban Areas Act, 1975 and the Rules 1976 made thereunder.
 - f) That licensee shall maintain and upkeep all roads, open spaces, public parks and public health services for a period of five years from the date of issue of the completion certificate unless earlier relieved of this responsibility and thereupon transfer all such roads, open spaces, public parks and public health services free of cost to the Govt. or the local Authority, as the case may be in accordance with the provisions of Section 3(3)(a)(iii) of the Haryana Development and Regulation of Urban Areas Act, 1975.
 - g) That licensee shall construct your own cost, or get constructed by any other institution or individual at its costs, schools, hospitals, community centers and other community buildings on the land set apart for this purpose, within four years from grant of licence extendable by the Director for another period of two years, for the reasons to be recorded in writing failing which the land shall vests with the Government after such specify period, free of cost, in which case the Government shall be at liberty to transfer such land to any person or any intuition including a local Authority, for the said purposes, on such terms and conditions, as it may deem fit, as per the provisions of Section 3(3)(a)(iv) of the Haryana Development and Regulation of Urban Areas Act, 1975.

- h) That licensee shall integrate the services with HUDA services as per approved service plans and as & when made available.
- i) That licensee shall make arrangements for water supply, sewerage, drainage etc. to the satisfaction of DG, TCP till these services are made available from External Infrastructure to be laid by HUDA.
- j) That licensee understands that development/construction cost of 24/18 m wide major internal roads is not included in the EDC rates and licensee shall pay the proportionate cost for acquisition of land, if any, alongwith the construction cost of the same as and when finalized and demanded by DGTCP, Haryana.
- k) That licensee shall submit NOC as required under notification dated 14.09.06 issued by Ministry of Environment and Forest, Govt. of India before actual execution of development works at site.
- l) That licensee shall obtain clearance from Competent Authority, if required under PLPA, 1900 and any other clearance required under any other law.
- m) That licensee shall pay the labour cess charges as per policy dated 4.5.2010.
- n) That licensee shall provide rain water harvesting system at site as per guidelines/ notifications/norms of Central Ground Water Authority /Haryana Govt., as applicable.
- o) That licensee shall make the provision of solar water heating system as per recommendations of HAREDA and shall make it operational, where applicable, before applying for Occupation Certificate.
- p) That licensee shall use only CFL fittings for internal as well as for campus lighting.
- q) That in compliance of Rule 27 of Rules 1976 & Section 5 of Haryana Development and Regulation of Urban Areas Act, 1975, licensee shall inform account number and full particulars of the scheduled bank wherein licensee has to deposit thirty percentum of the amount from the flat holders for meeting the cost of internal development works in the colony.
- r) That licensee shall arrange electric connection from outside source for electrification of your colony from HVPN and shall install the electricity distribution infrastructure as per the peak load requirement of the colony for which licensee shall get the electrical (distribution) service plan/estimates approved from the agency responsible for installation of external electric services i.e. HVPN/UHBNL/DHBNL Haryana and complete the same before obtaining completion certificate for the colony
- s) That licensee shall deposit thirty percentum of the amount realised, from time to time, from the plot holders within a period of 10 days of its realization in a separate account to be maintained in a scheduled Bank. This account shall only be utilized by you towards meeting the cost of internal development works in the colony.
- t) That licensee shall keep pace of construction atleast in accordance with the sale agreements with the buyers of the flats/shops as and when scheme is launched, after approval of building plans.
- u) That licensee shall permit the Director or any other officer authorized by him to inspect the execution of the layout and the development works in the colony and to carry out all directions issued by him for ensuring due compliance of the execution of the layout and development works in accordance with the licence granted.
- v) That licensee shall get extended validity of Bank Guarantee against EDC up-to 5 years (from the date of grant of license) and submit Bank Guarantee amounting to Rs. 73.75 lac against IDW (valid upto 5 year), within a period of 30 days from the grant of license.
- w) That licensee shall not create third party rights/pre-launch before approval of building plans.



x) That licensee shall obey all the directions issued by this Department from time to time in public interest.

4. The license is valid up to 07/8/2019.

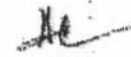
