Your site is located at a distance 21069 mts from ARP and lies in the grid V8 of the published CCZM of I.G.I Airport. The Permitted top elevation for this grid is 370 mts.

Since the requested top elevation 263.81 mts in AMSL is below CCZM permitted top elevation, the NOC for height clearance is not required from Airports Authority of India.

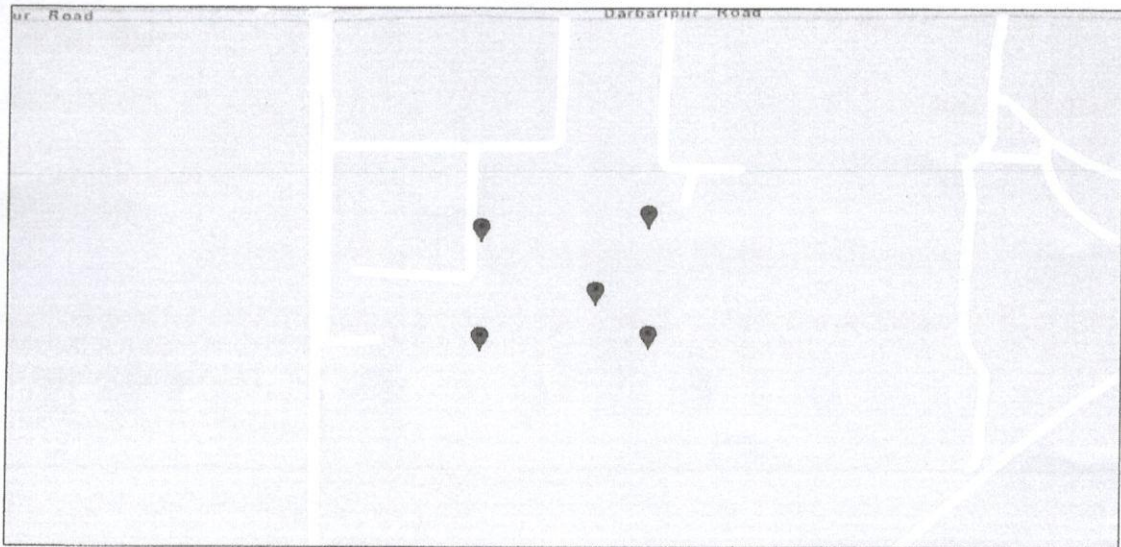

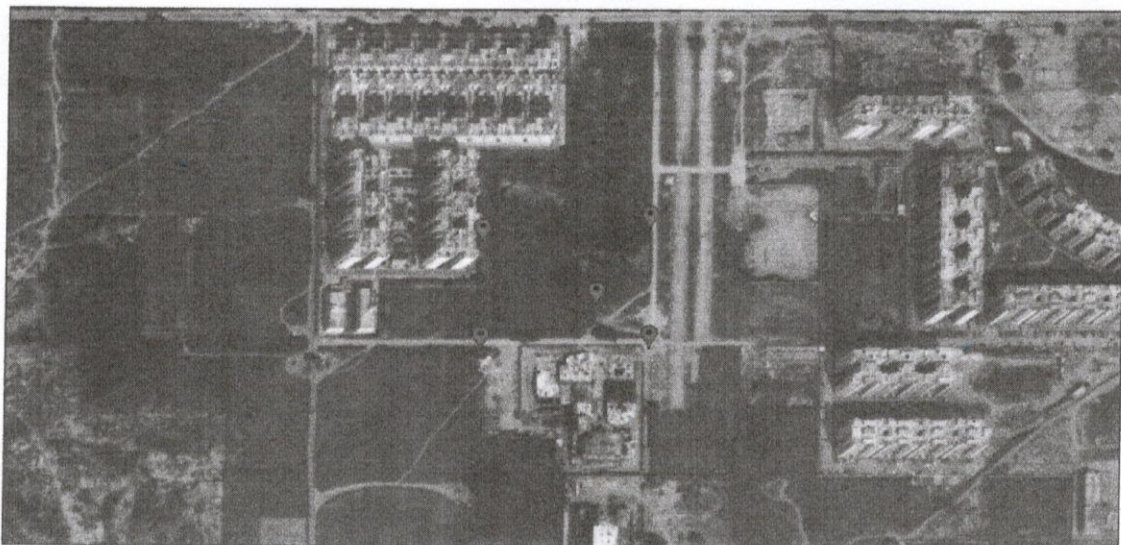
